Subject: Tree Removals Near Pacific Gas & Electric Co. Steel Gas Pipelines in the City of Lafayette

SUMMARY

Consulting Arborist Randall Miller, representing Pacific Gas & Electric Company (PG & E) and I agree that removal of trees in poor and very poor health that are located near steel gas piplelines in Lafayette, can be removed as a step towards improving the health of the urban forest in Lafayette, while in no way agreeing or disagreeing with PG & E about their contention that these trees are harmful to steel gas pipelines in the City of Lafayette (City). My analysis of tree data collected by PG & E and myself shows that

- eighty six protected trees are dead or in poor or very poor health
- one hundred and one trees are in fair or good health
- eighteen trees have already been removed, with no explanation provided as to who removed them or why
- two trees were not evaluated for health in 2022

Methodologies that PG & E used for determining which trees to remove near steel gas pipelines was presented by PG & E team members, and suggestions were made by City team members, but agreement was not reached between the two teams, beyond general agreement on removal based on tree health.

In addition to agreeing to the removal of trees in poor and very poor health, I recommend:

- Implement a level 1 tree risk assessment of large trees that are located next to large trees proposed for removal, in order to reduce risk caused by changes in wind patterns
- Plant and maintain new trees, shrubs, forbs, and grasses in areas near trees removals
- Manage trees that are damaging infrastructure or threatening fire safety using standard professional arboricultural practices that include but are not limited to crown pruning, mulching, irrigating, root pruning, and installation of root barriers

INTRODUCTION

ASSIGNMENT

The City of Lafayette (City/Client) hired me as a consulting arborist to provide my opinions about trees proposed for removal by PG & E. My assignment was to meet with a Tree Advisory Team (Team) that included pipeline experts & arborists, discuss tree removals with the Team, develop criteria for deciding which trees to remove, jointly conduct a "risk assessment" of trees that PG & E wanted to remove, and provide a written report.

LIMITS OF ASSIGNMENT

- Covid 19 prevented in person meetings and prevented me from observing new mapping and evaluations that PG & E carried out on trees in Lafayette.
- My opinions related to steel gas pipelines and risk posed by tree roots is not part of this assignment.

BACKGROUND

Trees of different species, sizes and in a variety of locations are protected in the City of Lafayette. To remove protected trees, individual trees are evaluated based on tree size, species, health, structure, form, habitat and relationship with other trees and landscapes. PG & E applied for a permit to remove protected trees near steel gas pipelines, which was granted in a negotiated process with the City.

My Client hired me to provide valuations of protected trees that PG & E wanted to remove, after locating, identifying, measuring, evaluating and tagging 273 trees (2016, Baefsky). The City requested reimbursement for the value of trees removed, with the proceeds used for tree planting within city limits. Removals were not carried out due to the objections of a citizen's group (Save Our Trees Lafayette) and subsequent lawsuits.

The City and PG & E convened a Team of four subject matter experts to try and come to agreement about trees to remove that included two steel gas pipeline experts, Richard Kuprewicz, President of Accufacts Inc. & Benjamin C. Mittelstadt, Professional Engineer and Director of Technical Services with Dynamic Risk, & two consulting arborists, Randall Miller of CN Utility Consulting, and myself.

OBSERVATIONS

METHODS

- I met with the Team online and discussed trees and steel gas pipelines in the City of Lafayette, how PG & E decides which trees it wants to remove, and issues related to steel gas pipeline safety.
- Discussions and written communications that I carried out with the team included attempts to formulate joint agreed upon statements between myself & PG & E representative, Arborist Randall Miller.
- I reviewed tree data & literature provided by PG & E, the City of Lafayette Tree Protection Ordinance, Best Management Practices & American National Standards Institute standards for tree care, Richard Kuprewicz's reports, Randall Miller's reports and other relevant information.
- In 2022 PG & E re-mapped & re-assessed 207 individual trees. They evaluated tree "condition", which appeared to be identical to what professional arborists define as tree "health".
- A PG & E forester and staff carried out the mapping & tree evaluations, along with input from a PG & E Certified Arborist, but did not tag trees or evaluate them using identical categories to my 2016 work.
- Randall Miller made a field visit the week of February 7, 2022, primarily in the Lafayette Reservoir Area, and he reported general agreement with my 2016 assessments
- Niroop Srivatsa (City Manager), Greg Wolf (City Planning Director), and Mala Subramanian (City Attorney) reviewed my report & provided critical comments regarding adherence to the original assignment, suggestions for improving clarity and brevity, and additional comments. I incorporated recommendations that improved the accuracy, clarity and brevity of the report, while adhering to the original assignment.

FINDING

Randall Miller and I agreed that the removal of trees in poor and very poor health is a reasonable action to take that can improve health of the population of trees in Lafayette.

DATA see Appendix A for full Data Set

- 2 trees were not evaluated for "health" or "condition" in 2022, these are identified by PG & E as VEGPT NAME 004143, and 005935
- I evaluated health of one of the two trees (#222) in 2016, but not the other one, which according to PG & E is one of a clump of five "brush cherries"
- 18 trees have already been removed
- 86 trees are dead, in poor or very poor health
- 11 of the dead, poor or very poor health trees are not protected in the City of Lafayette because they do not meet any of the criteria set forth in 6-1702(q) "Protected Tree"
- 101 trees are in fair or good health and should be preserved in my opinion, based on their health

RECOMMENDATIONS

1. Remove trees evaluated that are in poor and very poor health.

Safety Standards should comply with ANSI z133-2017 Safety Requirements including but not limited to general safety requirements, safe use of vehicles and towed equipment, safe use of portable power hand tools, and hand tools, and all relevant standards relative to Tree Removal (Section 8.6).

- 2. Implement a level 1 tree risk assessment near large trees that are to be removed, including includes evaluating large trees, structures, and other targets prior to removal of the trees in question, and incorporate options to minimize risk caused by removals including but not limited to pruning to reduce risk.
- A Level 1 assessment is a limited visual assessment, intended for quick assessment of large populations of trees. They are usually performed from one side of a tree (or from above) and typically look for obvious defects that can lead to moderate, high, or extreme risk.
- The assessor determines if the removal is likely to cause a root, trunk or branch failure in the coming year in normal weather, which could lead to moderate, high or extreme risk.
- Trees with elevated risks should be tagged and risk reduction mitigation measures recommended and implemented including carrying out a more advanced risk assessment if needed.
- 3. Manage area around trees removed as a utility corridor and include where appropriate planting new trees, shrubs, forbs & grasses, as well as mitigating damage to infrastructure or threatening fire safety.
- Management goals include replacing ecosystem services previously provided by trees that are removed including but not limited to soil erosion control, shade, screening, creation of views, and wildlife habitat.
- Routine monitoring of these sites is recommended to ensure that management goals are being reached.
- City Arborist/Landscape Architect shall evaluate areas proximal to trees being removed and develop a draft site plan that shall be paid for by tree removal mitigation fees and implemented by City of Lafayette Contractors or Staff
